

2026 Economic Assessment of scuba diving in the Balearic and Canary Islands Challenge - Official Rules

Eligibility

The 2026 Economic Assessment of scuba diving in the Balearic and Canary Islands Challenge (“challenge”) is open to PADI dive centres in the Balearic and Canary Islands only (“Entrant”). Entrants must be renewed for 2026 and must not have an open Quality Management action. No purchase required and void where prohibited.

This challenge is administered by PADI AWARE Foundation.

General Rules and conditions

The goal of the challenge is for Entrants to engage with their divers in their dive store with the [Individual Diver Survey](#). PADI AWARE Foundation will compare survey responses between 15 May 2026 to 31 August 2026. Only individual survey responses received by PADI by 31 August 2026 will be counted.

Entrants do not need to register for the challenge.

Prizes

From the Individual Diver Survey responses that can be used for analysis on the economic assessment of scuba diving in the Balearic and Canary Islands, the three PADI dive centres who have been named in the Individual Diver Survey the most will receive One (1) complimentary PADI membership renewal for the 2027 membership year. The ARV is between €565 - €800 depending on membership level.

By participating in the Challenge, Entrants agree to be bound by these Official Rules.

Winner Selection

PADI AWARE Foundation will determine the winners, once the Challenge concludes on or about 31 August 2026. The three Entrants with the highest mentions in the Individual Diver Survey wins the prize. In the event of a tie, the Entrants who have been a consecutive PADI member for the longest period will be selected.

Winners must be affiliated with PADI EMEA as of 31 August 2026. Winners will be notified by email on or about 3 September 2026.

Other rules related to the Challenge:

Disputes: Except where prohibited by law, entrants agree that: (1) any and all disputes, claims and causes of action arising out of or connected with this Challenge or any prize awarded shall be governed by and construed exclusively in accordance with California laws, without regard to its rules on conflicts of laws, and shall be resolved individually, without resort to any form of class action; (2) any action at law or in equity arising out of or relating to the Challenge, or awarding of the prizes, shall be filed only in the competent courts in accordance with the rules of California and entrants hereby consent and submit to the personal jurisdiction of such courts for the purposes of litigating any such actions; (3) any and all claims, judgment, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Challenge, but in no event attorneys' fees; and (4) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claims, indirect, punitive, incidental and consequential and any other damages (other than for actual out-of-pocket expenses), and any and all rights to have damages multiplied or otherwise increased.
